- **Butterfly Auction**

 - About 50% reduction from last year, but was better than expected.
 - Classroom artwork was missing which is usually \$10K.

Lottery

- o 3 or 4 of students have declined places.
- o We pulled a small handful for 2nd round.
- o 10 retentions this year, Coronavirus wasn't the major reason for this.
- Two new charter schools opening up in Wesley Chapel. A couple of students have gone to those schools. Pinecrest and Innovation. Not Montessori.
- Mental Health Assistance Approvals completed over email
- School Lunch Approvals completed over email
 - We are the only charter school who are on our own as we don't prepare our own lunches. Michael will bring this back for further approval when the RFP is completed. Everything should be complete by the end of the July if responses are received from the State.
- Budget Amendments
 - Nancy sent out some budget amendments based on changes to the budget. Board reviewed the changes.
 - Andy motioned to approve the budget amendment, Victoria seconded and Glenn and Eric also approved
- CMCS Policy Approval
 - o Board will review and approve over email or at the next meeting
- School Updates:
 - Loan Application is in the queue with the bank. Mary is reaching out to the bank last week. She is waiting to hear back from the bank the status says under review. Glenn had the same issue with PPP loans it is likely that the loan isn't being processed. Glenn to reach out to Bank of Tampa. Mary to try BBT on Thursday or Bank of Tampa on Thursday.
- Back to school update information in draft form.
 - Gov De Santis wants schools opening at full capacity in August. 6 ft distancing will not be possible and they are aware of that. District sent out a survey about returning to school. District has 3 option plans: (1) student returns to school (2) child remains a student but embarks on online education in school hours (3) complete online school we lose funding for that item and they would have to go into the lottery. District is expecting teachers to return in August. CARES act may have any additional funding for the cleaning and sanitation etc.
 - o Plan to get a full time custodian
 - o Once a parent commits are they bound to that for a period of time etc.
 - Need to consider what materials they have to have at home
