A meeting of the Board of Directors of the Countryside Montessori Charter School, Inc. (CMCS) was held at the school on Tuesday, September 22, 2015.

#### Call to Order:

Director Michelle Ferraro who declared that a quorum was present and that the meeting was open for business called the meeting to order at 1547 hours.

#### Roll Call:

In attendance: Directors Michelle Ferraro, Niketa Patel and Robin Blinder. Also in attendance were Mary Rivers, Lori Spurr, Dr. Michael Rom, and Jack Licht.

#### Approval of Minutes:

The minutes from the September 22, 2015 meeting were reviewed. Director Niketa Patel motioned for approval. Director Robin Blinder seconded the motion. A unanimous vote of 3/0 was entered and **APPROVED** by a signature of a majority of Directors.

#### Approval of Financials:

Financials from August (including regular comparison to actual budget) were reviewed. Director Michelle Ferraro motioned for approval. Director Niketa Patel seconded the motion. A unanimous vote of 3/0 was entered and **APPROVED** by a signature of a majority of Directors.

#### Old Business:

1. New BOD Member – Robin Blinder completed her fingerprinting. She is still waiting on testing. Nancy Agudo will check on the delay from our training vendor.

#### New Business:

- 1. Categorical spending was reviewed by the board (Personnel, Instructional, Lottery, ESE, Safe Schools, and Supplemental Academics). Director Michelle Ferraro motioned for approval. Director Niketa Patel seconded the motion. A unanimous vote of 3/0 was entered and **APPROVED** by a signature of a majority of Directors.
- 2. School Grades / FSA the board was presented with and reviewed the FSA report. CMCS performed very well and above District average in all categories in all grades. There is still no definitive decision from District as to school grades or funding connected to school grades.
- 3. FTE count = 292 students.
- 4. There are 4 adjacent lots available for purchase. The front lot includes a home. The Board made an offer of \$75,000.00 (see attached). That offer was declined. A counter offer of \$100,000.00 was discussed with a max offer of \$125,000.00 for all four parcels. Director Michelle Ferraro motioned for approval. Director Robin Blinder seconded the motion. A unanimous vote of 3/0 was entered and **APPROVED** by a signature of a majority of Directors.
